The regular meeting was called to order by Town Supervisor William Farber on May 14, 2013 @ 7:01^{pm}.

Hugh: Roads are open and the weight limit signs are going to come down; sanders are off & getting ready for summer work.

Wes: Wanted to know if the Road & Gun could use the rec center for Sept 14 for a spaghetti dinner and the FNRA Sept 21
